Adequacy of the process for determining facts Section 13-362(a) provides: "(a) A person who participates in or profits from a violation of law shall be guilty of a class 2 misdemeanor and, except as provided in subsection (b) of this section, may be imprisoned for not more than one year and may be fined not more than \$1,000. A person who violates subsection (b) of this section is guilty of a class 1 misdemeanor, and may be imprisoned for not more than one year or fined not more than \$1,000 or imprisoned not more than six months and fined not more than \$1,000, or both. A person who violates subsection (c) of this section is guilty of a class 3 misdemeanor. "(1) An individual, corporation, partnership, or association that participates in the management, leasing, or control of an illegal gambling business or the illegal possession of a gambling device is guilty of a class 2 misdemeanor. "(2) A person who engages in the business of accepting wagers for or on behalf of a person who knowingly or intentionally and for no reason other than to produce income engages in the business of accepting wagers is guilty of a class 2 misdemeanor." (Emphasis added.) In State v. Corcoran, 80 N.M. 148, 452 P.2d 852 (1969), this Court held that the second paragraph of this statute provides that
