A statute that requires child support to be paid in accordance with applicable child support guidelines is unconstitutional as applied to a poor pro se litigant who has no attorney, who has a nonsupporting partner and no minor children and who has no income, earning or property. *Morsette*, 904 So.2d at 458. Such a defendant is deprived of "fundamental fairness." Finally, as to the merits of *Morsette's* appeal, we note that the trial court found that *Morsette* does not have adequate housing or food to meet her basic necessities and that, if she were able to provide such, she would not be in contempt of court. It is undisputed that she has not paid the child support as ordered or as determined by the child support guidelines. A trial court can order a defendant to pay arrearage and can order incarceration, as the trial court did in the case before us. Applying the standard of review enunciated in *Ex parte D.J.*, supra, we hold that the trial court did not abuse its discretion in ordering *Morsette* to pay \$100.00 per month to her arrearage, in setting the payment schedule at \$200.00 a month, in assessing
