Pdf Author Pro Essential Crack.A Guide to Using the 24-Hour Billing Format On January 1, 2013, the first 24-hour billing format will go into effect in Ohio. The new format is based on the concept of hourly billing for all general-type contractors who perform work on state construction projects. The key change is that the number of hours performed on a project will now be reported on a standard monthly basis rather than on an hourly basis. For example, the hour of January 3, 2013 will be reported as "8 hours", rather than "8 hours," which is the hourly format in use before the implementation of the new monthly format. Ohio Revised Code §4961.01 requires any contractor who performs work or renders services on state-funded construction projects to be billed in accordance with the new 24-hour billing format. The statute also requires that any contractor who does not comply with the new format must be billed at the hourly rate at least once during each billing period. Although these changes are more important for large, in-house general contractors, contractors with small construction companies are also subject to enforcement. Contractors who fail to bill properly can face sanctions ranging from monetary fines to losing the contract, as well as professional disciplinary action for violation of a professional code of ethics. Fines Administrative fines can be significant. The range is between \$25 and \$500 per day. For construction projects that are ongoing, the penalty is \$75 per violation. A contractor must pay the fine up front, unless they can show that the violation was an oversight or an obvious error. Contractors can also be subject to discipline or other action by a court if they have shown a willful disregard for compliance with the law.
